Date: February 28, 2025

I conducted the February 2025 audit of the Flock System per East Palo Alto Police Department Policy 428. The audit is from February 1st through February 28th. The Flock system has captured 3,814,465 reads for 2025. During the audit period officers conducted 1,149 searches. All of these searches were made within policy with valid cases numbers or reasons for the search. All East Palo Alto searches conducted were made within policy with a valid reason or case number.

As of today's date, we have 24 of the 25 cameras live. We are still awaiting a permit to install the last camera.

East Palo Alto Flock cameras notable activity:

- 1) February 2, 2025 – Flock alerted on a stolen vehicle entering East Palo Alto. Officers located the vehicle unoccupied and returned it to the owner.
- 2) February 2, 2025 - Flock alerted on a stolen vehicle entering East Palo Alto. Officers located the vehicle unoccupied and returned it to the owner.
- 3) February 3, 2025 – East Palo Alto Officers utilized Flock to identify a vehicle used in a brandishing of a firearm investigation. The vehicle returned later in the day, the suspect was arrested, and firearm recovered.
- 4) February 4, 2025 - East Palo Alto Officers utilized Flock to identify a hit and run vehicle.
- 5) February 9, 2025 - East Palo Alto Officers utilized Flock to identify a vehicle used in a domestic violence case.
- 6) February 10, 2025 – East Palo Alto Officers were notified of a stolen vehicle enter the City. Officers located the vehicle in the Ravenswood Shopping center. The driver observed officers and fled at a high rate of speed. Officers did not pursue the vehicle for public safety reasons and notified local agencies to be on the lookout.

- 7) February 12, 2025 – East Palo Alto Officers were alerted of a stolen vehicle entering the city. Officers located the vehicle and a traffic stop was attempted. The driver fled and officers did not pursue. The vehicle was later located abandoned, and returned to the owner.
- 8) February 12, 2025 – East Palo Alto Officers were alerted of a stolen vehicle entering the city. Officers located the vehicle, which stopped on its own. The driver decided to flee the traffic stop and a pursuit was not initiated. Unmarked units were able to keep eyes on the stolen vehicle, which crashed into a parked vehicle. Following the crash, officers were able to get the driver in custody.
- 9) February 12, 2025 – East Palo Alto Officers used Flock to find the license plate of a hit and run suspect vehicle.
- 10) February 13, 2025 – East Palo Alto Officers used Flock to locate a vehicle involved in a hit and run. Officers located the suspect's license plate, and the case is pending follow-up.
- 11) February 13, 2025 – East Palo Alto Officers used Flock to locate a vehicle involved in a hit and run. Officers located the license plate, located the vehicle, and contacted the driver, who admitted to leaving the scene of the collision. The case was sent to the District Attorney's Office for an arrest warrant.
- 12) February 16, 2025 – Flock assisted East Palo Alto Officers in identifying a suspect who punched a McDonalds employee in the drive-through.
- 13) February 19, 2025 – Flock assisted East Palo Alto Officers in narrowing down a timeline of a missing person at risk.
- 14) February 20, 2025 – Flock assisted East Palo Alto Officers in locating a stolen vehicle. The vehicle was located occupied and the driver was arrested on multiple charges.
- 15) February 24, 2025 – Flock was utilized by detectives to locate the plate on a shooting that occurred in East Palo Alto.
- 16) February 26, 2025 – Flock assisted East Palo Alto Officers in locating a license plate on a hit and run vehicle.
- 17) February 26, 2025 – Flock helped locate an occupied stolen vehicle. The suspect was arrested and the vehicle was returned to the owner within two hours of it being stolen.
- 18) February 26, 2025 – Flock assisted East Palo Alto Officers in solving a hit and run collision. The driver was located.
- 19) February 27, 2025 - Flock alerted East Palo Alto Officers of a vehicle used in a shooting on February 24. The vehicle was located occupied and detectives were able to interview the occupants.
